**UNCONDITIONAL RELEASE OF LIABILITY – READ CAREFULLY**

- Warnings, Understandings, and Representations.** I understand the nature of Kayaking, Canoeing, Stand Up Paddle Boarding, and any other activity I might be engaging in involving **Waco Paddle Co., LLC** rental equipment in any context whatsoever. I understand that participation in these activities involves risk of serious bodily injury, including permanent disability, paralysis, and death. These risks and dangers may be caused by my own actions, or inactions, the actions or inactions of others involved in the Activities, the condition in which the Activities take place, the leased equipment and/or objects (including but not limited to the condition of said conditions and/or equipment), the actions and/or inactions of employees, agents, representatives, and/or owners of **Waco Paddle Co., LLC** (even if said action is negligent and/or reckless), or the recklessness or negligence of the Releases named below. With full knowledge of the risks and dangers, I represent that I am qualified, in good health, and in proper physical condition to participate in such Activities. I have inspected the equipment, facility, and Activities of **Waco Paddle Co., LLC**, and I find that they are acceptable for the intended use or participation.

I have read this agreement, fully understand its terms, understand that I have given up substantial rights by signing it and have sit freely without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law, and agree that if any portion of the agreement is held to be invalid, all remaining language shall continue in full force and effect.
